STANDING RULES

Standing Rules are established to aid in the administration of the Alumni Board of Directors and to ensure continuity in the work of the Board. These Standing Rules may be rescinded or amended by two-thirds vote without previous notice or by a majority vote with five (5) days' previous notice. These rules remain in effect until the Board rescinds them.

BYLAWS ARTICLE 6 MEMBERSHIP

ELEGIBILITY

- Anyone who has earned a degree from South Baylo University
- Anyone who desires to contribute for the Association

MEMBERSHIP

- Active Membership:
A contribution to the Association no less than \$100 or equivalent for each twelve (12) months
- Privilege of Active Membership:
 - 1) Free listing on the Association directory
 - 2) Free educational material access and download on website
 - 3) Free pass to thirty five (35) hours Continuing Educations a year provided by the Association to receive the credit.
 - 4) Discount on the Association's special lectures
 - 5) Eligible to hold the seat at the Board or recommend the Board Directors

BYLAWS ARTICLE 7 BOARD OF DIRECTORS

SECTION 4: ELECTION, DESIGNATION, AND TERM OF OFFICE

THE CHAIR OF THE BOARD

- QAULIFICATION
 - 1) Graduate from South Baylo University
 - 2) Current Board member
- ELECTION PROCEDURE
 - 1) Election Announcement: The first week of September of the term's last year

- 2) Election Date: Any day of the last week of October of the term's last year
 - 3) Election is determined by two third (2/3) of the Board of Directors' approval.
 - 4) Chair of the Board elected will be effective with two third (2/3) of the attended SBUAA members' approval at the SBUAA members' grand meeting
- THE RIGHT AND BEGINNING OF THE CHAIR OF THE BOARD-ELECTED:
 - 1) Immediate with Announcement, the Chair of the Board-Elected should attend all board meetings and access all files and data of the Board
 - 2) The Chair of the Board-Elected requests and receives all files and data including the bank account by end of the December prior to the new term
 - 3) The term begins the first day of January of the following year of election
 - 4) The Chair of the Board takes the roll of the President of Administration concurrently

THE BOARD OF DIRECTORS

- QUALIFICATION
 - 1) Graduate from South Baylo University
 - 2) Minimum two (2) years in active membership
- REQUIREMENT (must be submitted fifteen (15) days prior to the election date)
 - 1) Candidate Application
 - 2) Curriculum Vitae
 - 3) Emailed Recommendation submitted to the Board from minimum one third of Board Directors or three (3) Active Members
- APPOINTMENT PROCEDURE
 - 1) New appointment is determined at any Board of Directors meeting by two third (2/3) of the Board of directors
 - 2) New appointees are announced within one (1) week after the appointment
